PUBLIC QUESTION TO BE VOTED UPON

PROPOSAL

The Board of Education of the Toms River Regional Schools, in the County of Ocean, New Jersey (the "Board of Education"), is authorized: (a) to construct additions, renovations and improvements to Beachwood Elementary School, Cedar Grove Elementary School, East Dover Elementary School, Hooper Avenue Elementary School, North Dover Elementary School, Pine Beach Elementary School, Silver Bay Elementary School, South Toms River Elementary School, Walnut Street Elementary School, Intermediate North School, Intermediate East School, High School North, High School South and High School East; (b) to construct a five-classroom health services facility on the campus of High School South; (c) to construct an all-purpose athletic facility for use by all schools in the School District; (d) to make the necessary onsite and offsite improvements and purchase the necessary equipment associated with such improvements; (e) to appropriate for all of the foregoing \$13,426,148 to be funded in part by a \$3,983,126 grant from the State of New Jersey; (f) to issue bonds or temporary notes, if necessary, to finance the School District's local share of said purposes in the principal amount of \$9,443,022; and (g) to transfer any unexpended appropriation between and among the aforementioned projects.

The total final eligible costs approved by the Commissioner of Education for the project is \$13,426,148.

Bonds also are authorized to be issued for this purpose, including the \$3,983,126 of the State grant, for a total bond authorization of \$13,426,148, to permit financing for the entire cost of the project in the event that all or a portion of the State grant is not available to the School District. If the State of New Jersey is unable to provide any portion of the grant amount, the School District would be expected to receive 29.67% of debt service aid from the State of New Jersey while the bonds are outstanding. Temporary notes of the School District are authorized to be issued in anticipation of the receipt of the grant from the State of New Jersey and other funding sources. If necessary, the Board of Education is authorized to transfer by resolution General Fund surplus, Capital Reserve amounts, and investment earnings from the temporary notes and bonds authorized herein to complete the improvements listed herein.
